

## **1. HOW TO ENTER & ELIGIBILITY**

No purchase necessary. To enter, entrants (the "Referrer") must submit a successful referral for a new TELUS Business mobility rate plan customer ("Referee") at ([telus.com/referabusiness](https://telus.com/referabusiness)). Every successful referral will count as an entry. No other form of participation will be accepted. Each successful referral automatically gives the referrer one (1) entry to the contest. There is no limit to the number of referrals/entries submitted.

The Referee business cannot be a current TELUS Business mobility customer. The Referee must activate a new TELUS Business smartphone plan. This contest does not apply to Consumer or Corporate accounts.

Contest runs February 27, 2024 to March 31, 2024 at 11:59 PM ET. To be eligible entry must be received on or before the contest closing date with a successful referral taking place on or before April 14, 2024.

Entrants must be the owner of a company or business domiciled in Canada with 1-100 employees, less than 30 telecommunication lines and present an HST/GST number (QST number in Quebec), registration number, incorporation number, and/or other proof of business upon activation. (an "eligible business").
